A check or money order payable to the <u>TREASURER OF VIRGINIA</u>, or a completed <u>credit card insert</u> must be mailed with your application package.

APPLICATION FEES ARE NOT REFUNDABLE.

Applications must be accompanied by three written references from wetland professionals.

At least one reference must come from a certified professional wetland delineator.

## **Application Requirements**

All applicants must <u>meet the current eligibility requirements at the time the completed application package is received at the Board office</u>. Completed application packages must include all required documentation, references, certifications/registration verification, and fees. All forms must be legible. Applications must be submitted with the appropriate fee no later than 90 days prior to a scheduled examination. The date the <a href="completed">completed</a> application and fees are received in the Board office determines whether the applicant meets the application deadline. It is the applicant's responsibility to ensure that the Board receives the completed package prior to the established deadline. Submission of applications just prior to the deadline may result in late notification of eligibility to sit for the scheduled examination. Review of incomplete applications and applications received after the examination application deadline will be deferred to the next examination cycle.

**REQUIRED DOCUMENTATION** (including candidates that were previously approved and are reapplying for the examination):

- 1. A completed <u>Professional Wetland Delineator Certification Application</u> and fee;
- 2. Three current <u>Professional Wetland Delineator Reference Forms</u> (less than one year old) completed by wetland professionals (effective July 14, 2010, at least one of the three required references must come from a certified professional wetland delineator);
- 3. Completed *Professional Wetland Delineator Experience Logs* to document all required experience;
- 4. Certified/official transcript verifying the completion of the required bachelor's degree (if applicable); and
- 5. Individuals applying for certification in accordance with 18VAC145-30-50.1 must submit 10 delineation reports which prove that the applicant actually performed the field work. The reports must include a report cover page with the date and language stating that the applicant performed a specific amount of the field work, representative data sheets that list the applicant as the investigator, and a statement indicating that copies of the full report are available upon request. The delineations must be no more than 10 years old at the time of receipt by the Board office and at least six (6) of the 10 delineations must be for non-tidal wetlands.

## **Examination Notices and Fees**

Each candidate will be sent a written notice of the time and place of the examination for which the candidate is eligible. Candidates shall promptly notify the Board as to whether they intend to appear for the examination. Failure to notify the Board may result in loss of eligibility for that particular examination. Each examination fee shall be applied to the next scheduled examination and may be forfeited for failure to notify the Board or failure to appear. Examination and reexamination fees must be received in the Board office no later than 30 days prior to the next scheduled examination.
